1. Ensure that health, safety and wellbeing is an integral part of the management of Palmer's Coaches and ranks equally with all other activities of the organisation.
2. Provide and maintain a safe and healthy workplace for Palmer's Coaches employees, contractors and visitors.
3. Remain committed to the Risk Management process and ensuring consistency with the nature of the workplace and risk assessment.
4. Commit to complying with all relevant Legislation, Codes of Practice and Statutory Requirements, and with all other requirements placed upon Palmer's Coaches or to which Palmer's Coaches subscribes.
5. Establish measurable occupational health & safety objectives and targets to ensure continuous improvement aimed at the elimination of work related injury and illness.
6. Monitor our work health & safety programs performance on a systematic basis.
7. Encourage and support employees', contractors' and visitors' contributions to the improvement of health & safety through appropriate consultation, communication, training and supervision.
8. Promote consultation between management, employees and contractors on matters affecting health & safety including any workplace changes that may affect health, safety and general wellbeing, and
